**Hon Jt Secretary** - A member who has been an elected member of the Executive Committee for a minimum period of three years with the attendance criteria detailed below in appendix 1

**Hon Treasurer** - A member who has been an elected member of the Executive Committee for a minimum period of three years with the attendance criteria detailed below in appendix 1

**Editor JIOS** - A member who has been an elected member of the Executive Committee for a minimum period of three year with the attendance criteria detailed below in appendix 1 & appendix 2 .

### **Appendix 1**

Eligibility Criteria : At the time of Scrutiny

1. For EC tenures upto IOS year 2006 – Nil Attendance
2. During IOS Year 2007 – 50% attendance
3. IOS year 2008 till date – attendance is 60 %

1. Have four publications as a first author at a state /national /international recognised peer reviewed journal / authored a chapter in a textbook of orthodontics
2. Should have been the Editor of a state /national Dental/Orthodontic peer reviewed journal

3. Chairman/ Co chairman or Scientific convenor of a state /national conference /convention of the IOS .
4. Authored a textbook of Orthodontics .
