1) Prospective candidates are invited to send in their applications in the prescribed formats Along with the application form, the following documents are required as proof of the work done made by the candidate ( for awards A) 1,2 and 3

#### 2) For award no. (A) 1

a, The submitted dissertation shall be a bonafide work done by the candidate two years prior to the year of applying for this award .b, listed above (dissertation) a letter may be submitted from the Guide / Co-guide / Head of the Department / Head of the College stating that the dissertation submitted is a bonafide work carried out by the candidate in the department, c,photocopies of the key articles (two to three articles) that may have formed the basis of the present study or may have had a significant bearing on the design of the present study along with a soft copy (CD) of the dissertation d,the candidate shall be a life member of the Indian Orthodontic Society of good standing at the time of applying for this award ..

### 3) For awards number (A) 2 & 3

listed above, enough proof that the work has been done by the candidate, in the form of a letter from the authority on the letterhead where the work has been carried out stating that it is an original work carried out by the candidate, should be submitted. the candidate shall be a life member of the Indian Orthodontic Society of good standing at the time of applying for this award ..

#### 4) For award number (A) 4

All research work submitted for this award shall be duly certified by the guide /Head of department as a genuine work done by the candidate .Only one research work work shall be submitted at one time by a member for consideration of award .Dissertations submitted for MDS shall not be considered .The study shall be a separate and independent work conducted by the student during post graduation .

## 5) For award number (A)5

All scientific articles published in JIOS of 2017 shall automatically be eligible for consideration for the award . Review articles published in JIOS shall not be eligible for consideration .Weightage shall be given for original research work when being considered for this award . . the candidate shall be a life member of the Indian Orthodontic Society of good standing at the time of applying for this award ..

#### 6) For award number (A) 6

An ethical committee clearance shall be furnished for animal experimentation/human clinical trials . Candidate shall submit photocopies of any key articles that may formed the basis of the present study. . the candidate shall be a life member of the Indian Orthodontic Society of good standing at the time of applying for this award ..

4)Certificates of Institution Ethical Committee Clearances(where applicable) for all award in category A need to be submitted. Applications with all additional documents as PDF scans
