- 3. This is to receive the registration link for elections. Registration for elections is MANDATORY in order to receive the voting link.
- 4. The registration link would be sent to your email ID (KINDLY ADD secretary@iosweb.net to your contacts to avoid the email going to spam).
- 5. Please note that updating your details on IOS website is NOT registration.
- 6. The registration form for IOS elections 2021 would also be made available on the IOS website and IOS FB.
- 7. Registration would start on 10th September and would complete on 20th September by 5 pm.\*Registration after the deadline will not be entertained.\
- 8. A confirmation email from IOS headoffice would be sent to all verified voters.
- 9. Voters who successfully registered and participated in the trial election would be considered registered for the final elections.
- 10. The voting link from contact@right2vote.in would be sent to successfully registered voters 24-48 hours before the election.Please add this email id to your contacts to avoid the link going to spam.

Interview of **Prof Dr K. Sadashiva Shetty** Who shall receive the **IOS Lifetime Achievement Award for Year 2021** At the inaugural Ceremony of 55th IOC Covered By Dr Kavitha Iyer, Associate Editor Prof Dr K. Sadashiva Shetty is one among a few renowned Academicians, whose name is etched in Orthodontic history in India. Many leading Orthodontists have been trained under his guidance not only for MDS but also for IBO and MOrth from more than 30 years. His dedication as a teacher and clinician is well known among the members in our fraternity. Life time achievement Award by IOS for the year 2021 is been awarded to him for his immense contribution to our society. He has a handful of international and national presentations and publications to his credit. Recently came out with a two volumes Atlas "A Case-Based Atlas of Comprehensive Orthodontics" for which legends like Dr Rangachari has given excellent review. A book worth reading to know all aspects of Orthodontics from last 3-4 decades. On behalf of IOS Times ,I thank you for sharing your valuable time with us.

Dr Kavitha lyer :- Sir, can we all know your educational and family background and who inspired you?

**Dr K. Sadashiva Shetty :-** I was born in the year 1954 in a place called Kundapur (Present Udupi district). This particular district was under Madras presidency and my father was in Madras Government Service. He worked as a faculty in Agriculture College, Coimbatore. My initial school education was in Kundapur till 7th Standard and from 8th onwards I studied in Kikani High School, Coimbatore. I did my Pre-University in Government Arts College, Coimbatore.

Dr Kavitha lyer :- Why you have selected orthodontics as your specialty?

**Dr K. Sadashiva Shetty :-** Joined the BDS course in the year 1971 and got my BDS degree in the year 1976. Those days it was Dental Wing, Madras Medical College and Dr.K.Ramachandran was heading the Dental Wing. After one year of Internship I joined MDS course in the year 1978. Those days there were few takers for MDS. Even though my first preference was Oral Surgery and as there were competition from service candidates I got into Orthodontics. Late Dr.J.G.Kannappan, Dr.S.Rangachari, Late Dr.M.R.Balasubramanyam and Dr.Venkatesan were the faculty in the department. We were four Post Graduates and the Course duration was Two years. The case load was quiet heavy. I cleared my MDS in the year March 1980.

Dr Kavitha lyer :- When and how did you enter Academics and your experiences as a teacher?

**Dr K. Sadashiva Shetty :-** It was my dad who pushed me to get into academics and I joined Bapuji Dental College and Hospital, Davangere on 7th August 1980. It was a new college having started in the year 1979 and joined as Lecturer in Orthodontics. I struck to this college and sequentially attained the grade of Reader, Associate Professor, Professor and HOD and Principal, Bapuji Dental College and Hospital, Davangere. I became Head of Institution in the year 1992. I was of 38 years of age and remained in that position until recently i.e, 2020. Presently I am working as Director in the same college. Throughout my tenure in the college I had a wonderful backing of my college management and whatever I have achieved is because of their whole hearted support.

Dr Kavitha lyer :- Your journey with IOS....

**Dr K. Sadashiva Shetty :-** I have been the Life member of Indian Orthodontic Society since the day I passed my MDS. I was elected as President for Indian Orthodontic Society during the year 2001. I became the Member of Indian Board of Orthodontics in the year 1999, Director in the year 2006, subsequently Chairman in 2010. I had conducted around 39 CDE Courses in PEA, Functional Appliances etc. I was been recognised as a Best Teacher by RGUHS in the year 2017.

Dr Kavitha lyer :- Sir, You list some of your prominent service to our Profession & Society?

**Dr K. Sadashiva Shetty** :- Organised State Dental Council and 1st South Zone Conference, Davangere in 1989 Organised State Dental Conference in 1995.

13th IOS PG Convention, Davangere in 2009.

Was External examiner for various PG examination, published many scientific papers in Orthodontics.


