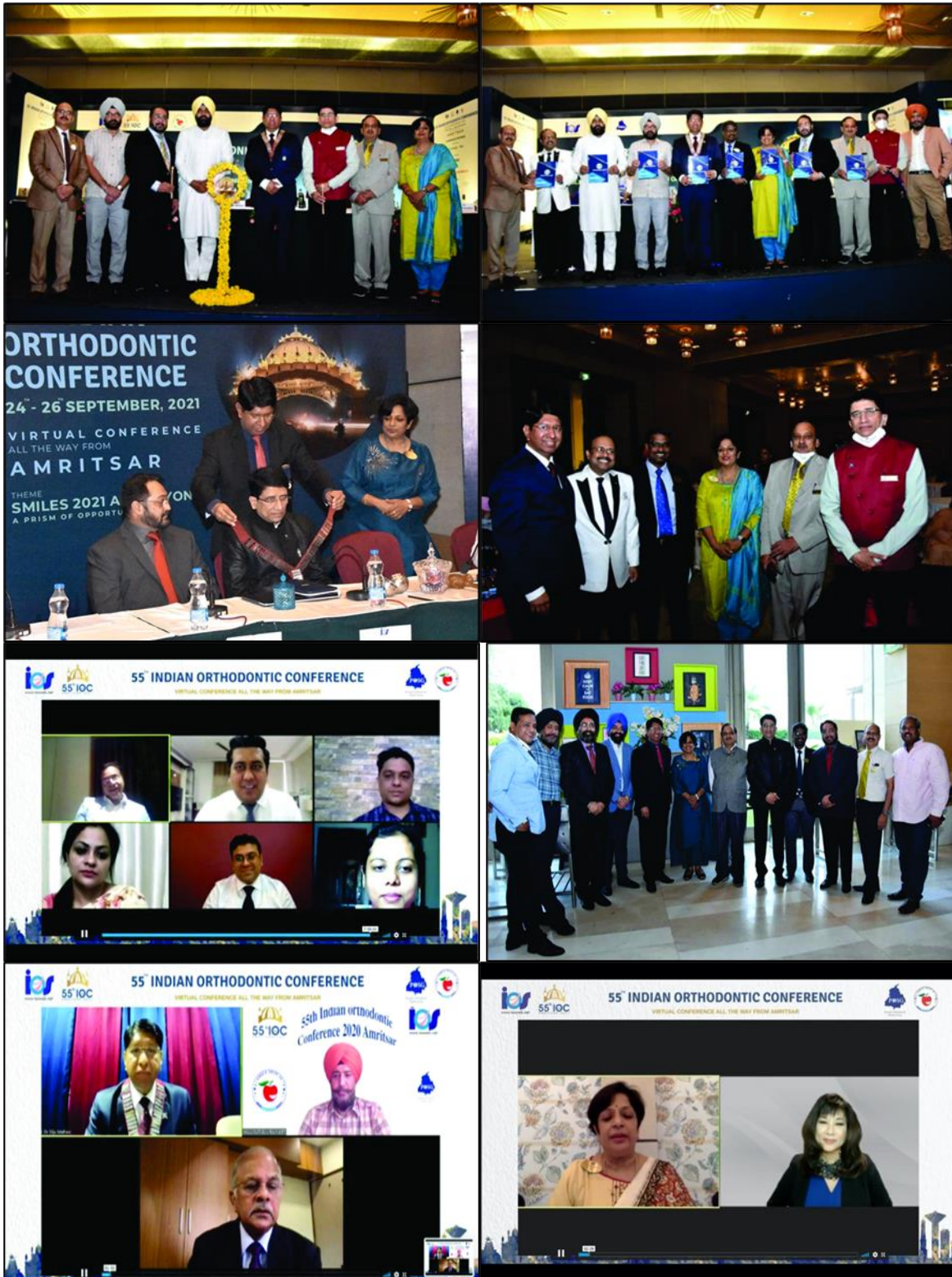

55TH INDIAN ORTHODONTIC CONFERENCE AMRITSAR

The 55th Indian Orthodontic Conference was conducted between 24th-26th September, It was the most awaited national conference of the historic Covid-era and the first ever virtual annual conference which was held under the theme "Smiles 2021 and beyond: a prism of opportunities" This annual virtual conference was organised from Amritsar by Dr.Jagpreet Singh Sandhu (Organising Chairman), Dr.Amanish Singh Shinh (Organising Secretary) and Dr.Sukhdeep Singh Kahlon (Scientific Chair). Although the event was virtual, the Principal office bearers travelled to the venue Dr.Silju Mathew (President IOS), Dr.Sridevi Padmanabhan (Hony. Secretary), Dr.Srikrishna Chalasani (President Elect), Dr.Pradeep Jain (Immediate Past President), Sanjay Labh and Dr.Gnanashanmugham along with other members of the Punjab Orthodontic Study group were physically present in Amritsar to oversee the online conference and the AGM and other details. The Scientific Programme was conducted on a digital platform in line with the social distancing norms due to the Covid 19 pandemic guidelines. On the recreational side, there was an online cultural night which was held on Day 2 of the conference. It was thoroughly enjoyed by all and was a success. IOS CARE is a flagship benefit scheme of IOS Member benefit Program. The program aims at providing financial assistance to the family of Deceased IOS Life Members provided the Member

has registered for the Scheme. Totally 16 families were shortlisted to receive the Benefit for the society year 2019-21 out of which 2 were not eligible because of Scheme Clauses. Based on the direction of 55th AGM the 14 families were entitled to receive the benefit irrespective of the registration status to the scheme. Committee members started collecting the family details of the deceased Life members.

The Data was collected as follows

1. Cause of Death
2. Surviving Class I Heirs and their contact details

3. Academic / private practise background of the Member As all the 14 deceased members were not registered members of the scheme, a legal opinion was Sought from the IOS Counsel as Guidance to decide on the Beneficiary of the fraternal contribution from IOS CARE. The Counsel suggested for Legal Heir certificate to decide on the Beneficiary. An Internal committee meeting was held to discuss on the Legal opinion followed by a POB Meeting. It was decided in the POB Meeting to refer to IRDA Guidelines pertaining to the decision on one Nominee/Beneficiary In case if the family doesn't possess a legal Heir certificate then as per the Schedule to the Indian succession act 1925, for your father's Estate the Class I Legal Heirs would be

1. Wife/Widow
2. Children
3. Mother

In that order of preference. A POB meeting was scheduled on 18th March for the approval of the same .With further EC approval the First surviving Class I heir was contacted through phone and an official letter was sent by the Hon.secretary to them conveying our condolence, Information about IOS CARE and process for claim of fraternal contribution. Received response from 10 family members out of 14 with relevant documents. All the documents were submitted again to IOS Counsel for his opinion and advice. Based on his advice an Indemnity bond and NOC affidavit has been requested from the beneficiaries. Disbursement will start immediately after the receipt of duly filled indemnity bond from the beneficiaries. Two Promotional videos were released to encourage members to register for IOS CARE which was widely shared and circulated in all relevant platforms/Forums Committee Chairman presented the video and explained about the scheme in a. First Practise management symposium and B.Bangalore Orthodontic study Group programme Committee members participated in various other IOS Programmes and shared information about IOS CARE to Life members. Currently there are 268 approved members in the scheme.

IOS PROTECT

IOS PROTECT is a Professional Indemnity scheme for IOS Life Members. IOS has tied up with New India Assurance to provide the service at a very nominal rate of 1077 per member per year for a sum of 20 lakhs. What started as a single policy in March 2020 for 132 members has successfully completed 3 years of renewal and three more additional policies serving our members throughout the year.

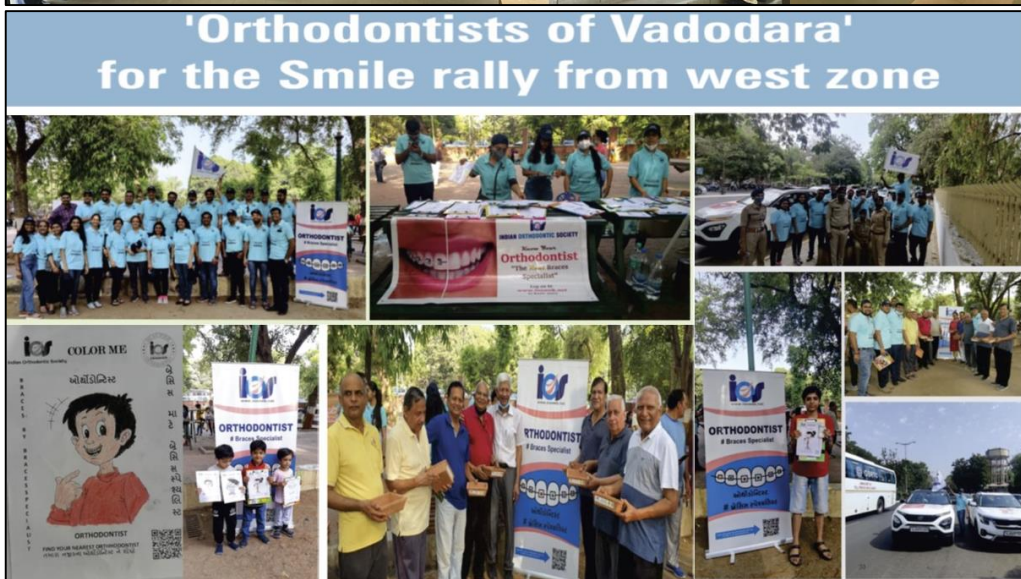

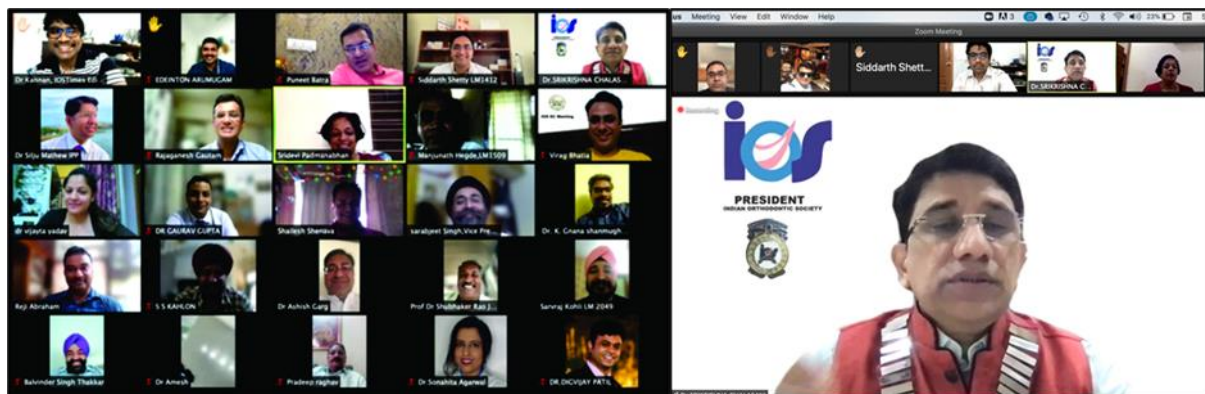

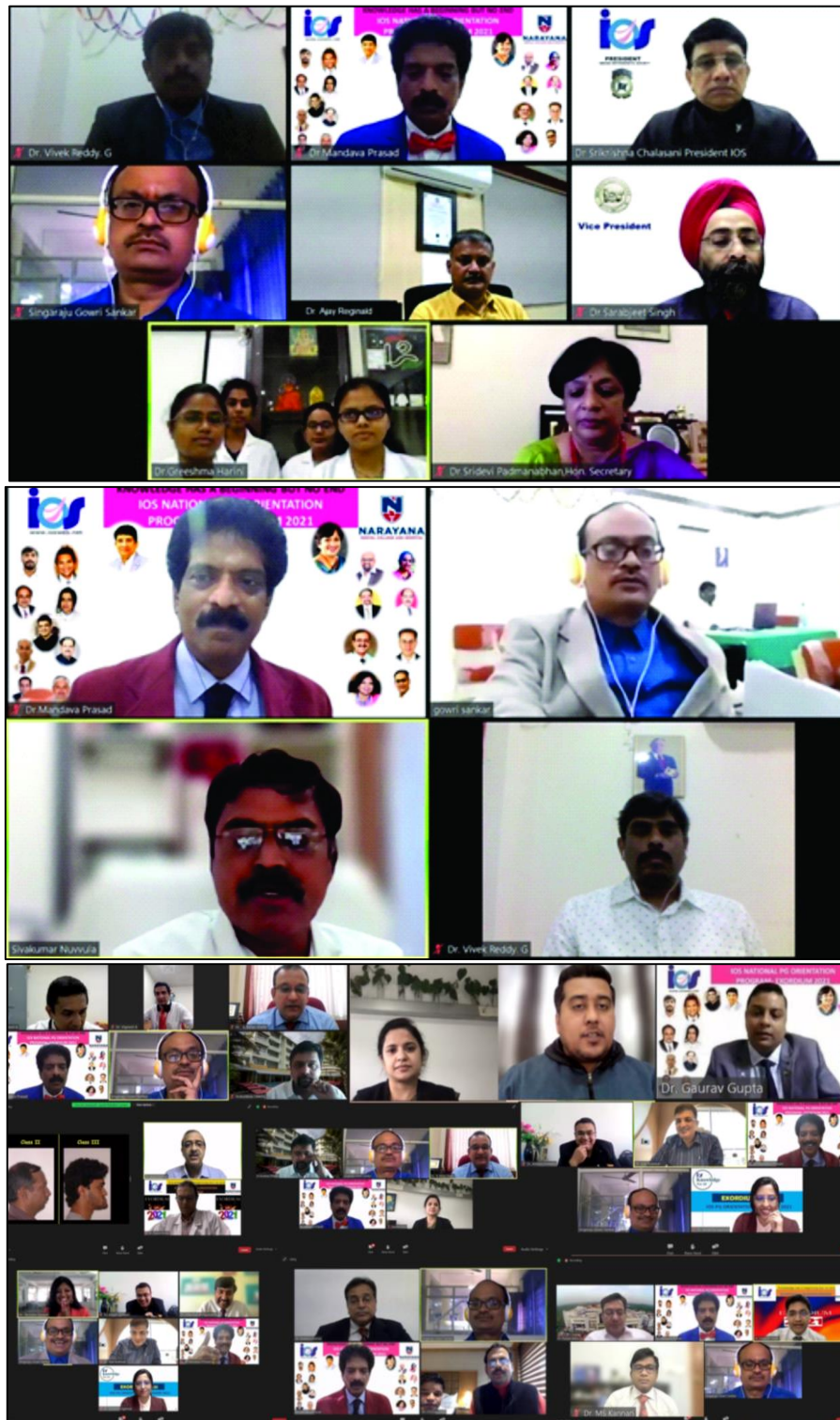


Exordium 2021 IOS PG Orientation Program 13th, 14th December 2021 Narayana Dental College, Nellore

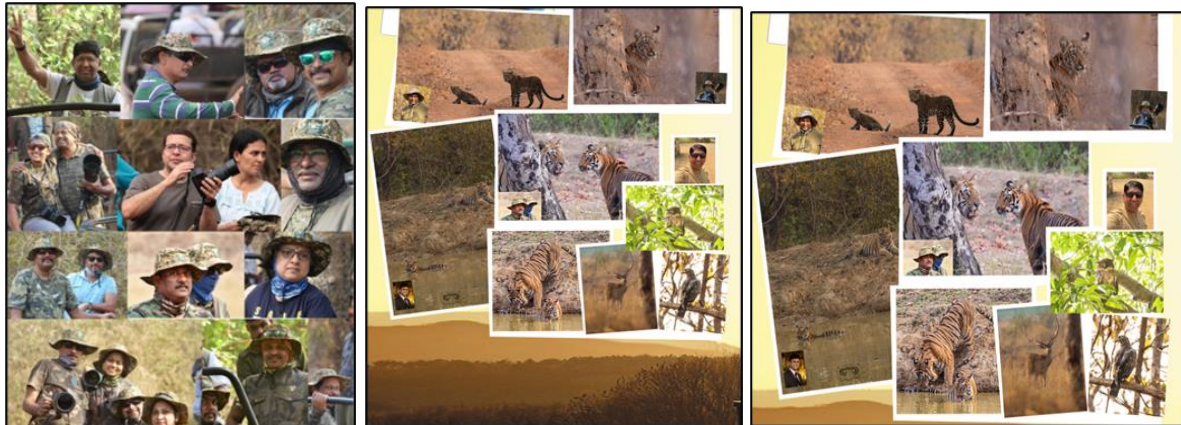

[IOS-ROAR 2022 Season 7 Ramachandra Orthodontic Accelerated Review 2022](#)

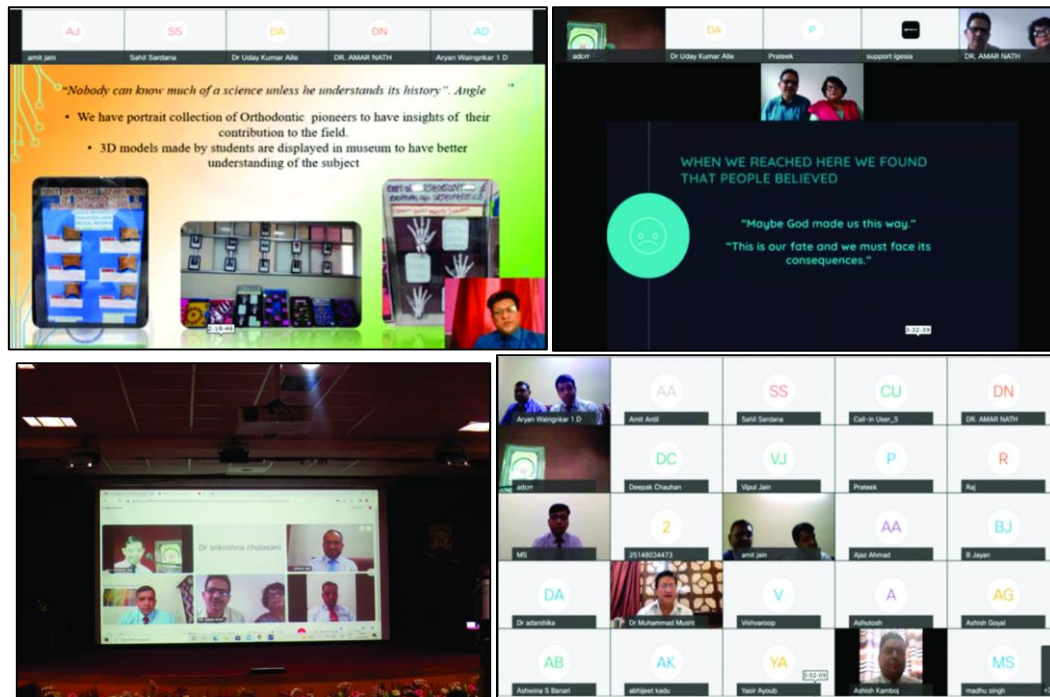

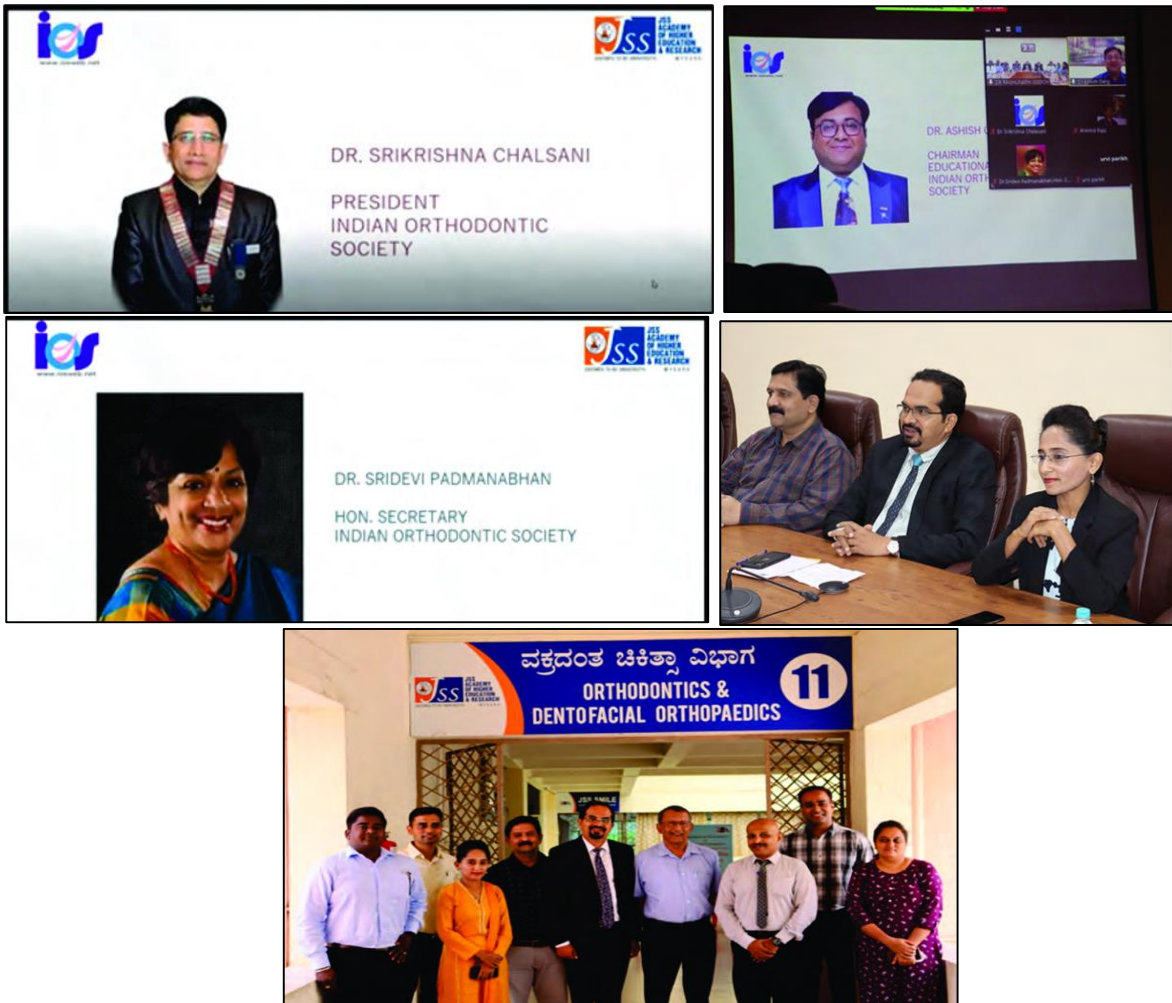

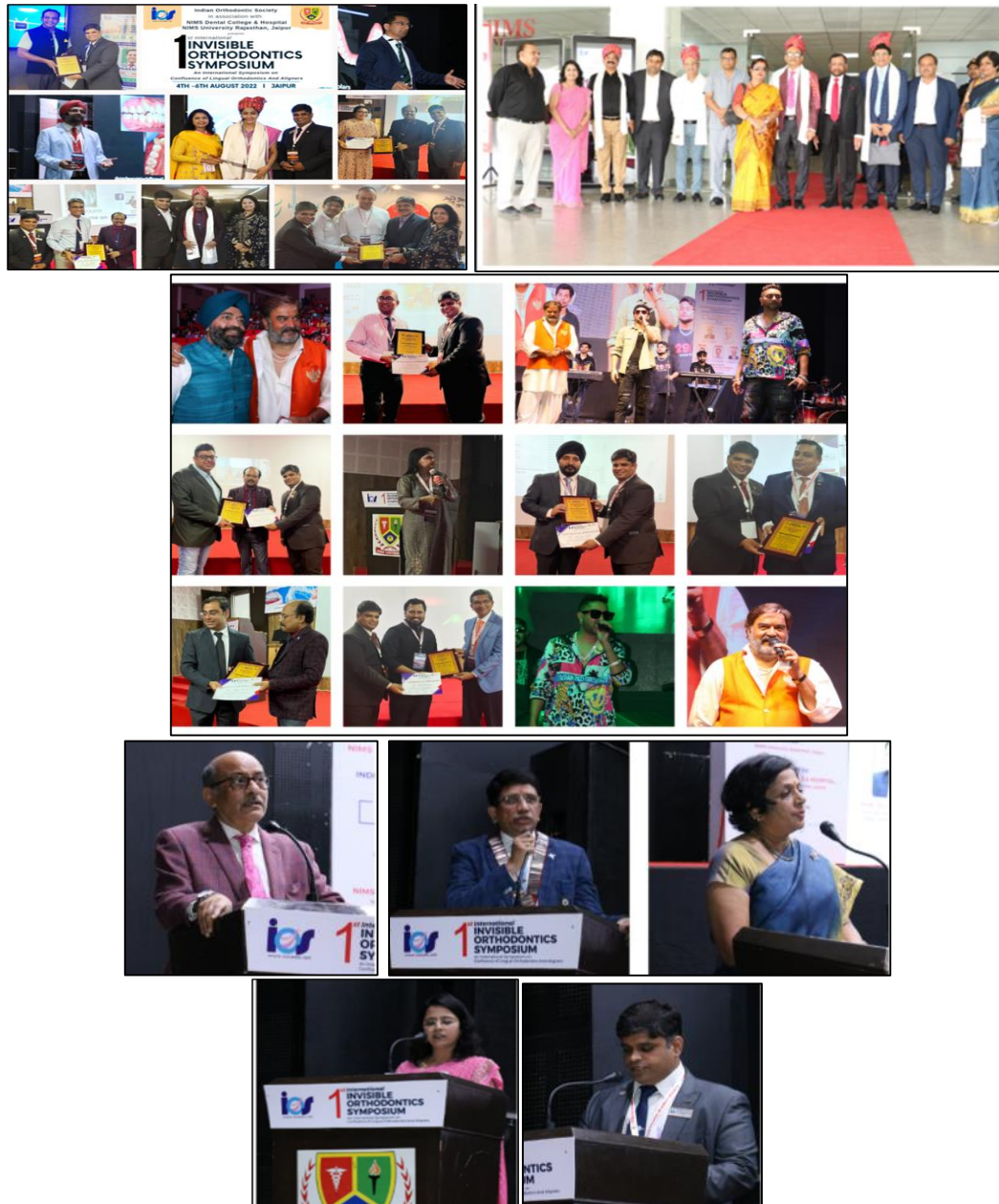


1st Invisible Orthodontics Symposium 2022, Jaipur

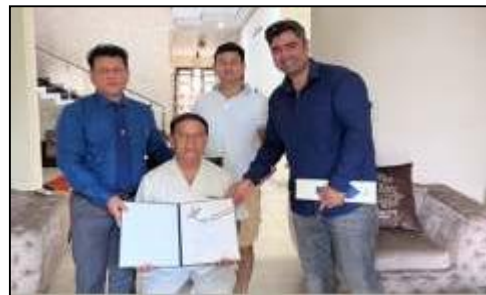

Speaker Name: Dr.Paolo Manzo

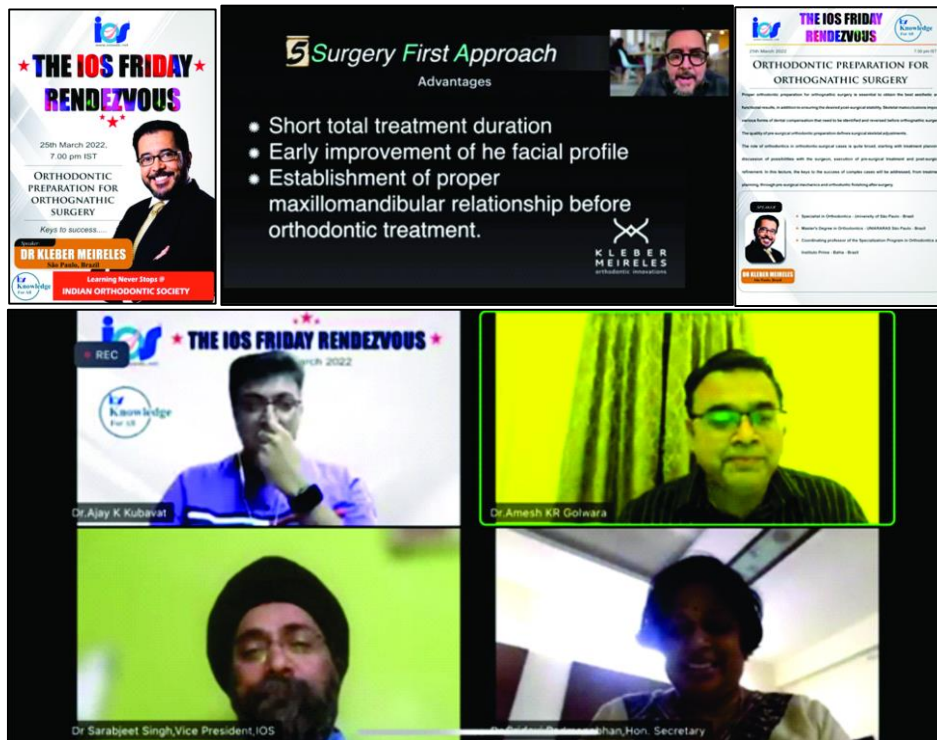

INDIAN BOARD OF ORTHODONTICS -ANNUAL REPORT

The Indian Board of Orthodontics (IBO) started its IBO year on the 18th September 2021 with Dr.M.Vadivelkumar taking over as Chairman of IBO from the immediate past Chairman IBO Dr. Ketan Vakil at the 22nd Convocation of the Board that took place at Saveetha Dental College and Hospital, Chennai. The Board of Directors (BoDs) for the year 2021-22 comprised of Chairman Dr. M. Vadivelkumar, Vice Chairman Dr. Ashwin George, Secretary and Treasurer Dr. Rajaganesh Gautam and Directors Dr. Salil Nene and Dr. Mala Ram Manohar. The IBO had a very fruitful and activity filled year in which the BoDs worked very hard along with the support of the President and Hon. Secretary IOS, and the entire Executive Committee of the IOS, towards realising goals that are aligned with the objectives, mission and vision of the IBO. The mission of the Board is to encourage a greater number of orthodontists to take up the exams and prove their excellence in the field of Orthodontics which collectively serves to raise the bar of clinical excellence in the practice of the specialty at large. The vision of the Board is to become a global leader in speciality Board certification practices for promoting excellence in Orthodontics and Dentofacial Orthopaedics and for establishing standards and parameters for professional care. We started off by conducting a very successful IBO Phase II exam on 20th February, 2022, as a pan India online exam at 32 centers spread across the length and breadth of the country.

A total of 286 candidates registered for the exam. Candidates had the comfort of appearing for the exam in their own or nearby city, that proved to be extremely cost and time effective and convenient and this year's exam was a very successful second stint as an online exam since the last year. This was followed by the first ever overseas IBO awareness program that was conducted at the Hotel Holiday Inn, Dubai on the 26th March 2022, with the help and coordination by our local IBO Diplomates and IOS members based in Dubai - Dr. M.P. Julius, Dr. Kedar Vartak, Dr. Sachin Mudrale and Dr. Ramesh Sablok. The program which was a huge success greatly benefitted our IOS brethren at UAE towards understanding the process and benefits of IBO Board certification. Dr. Moza Obaid Tahwara, President, Emirates Orthodontic Society (EOS) graced the occasion as the Chief guest along with Dr. Amna Al Shamsi, Dr. Khulood Al Hajeri, Dr. Shaima Al Naqbi, and Dr. Reji Moideen, members of EOS, as dignitaries at the program. This initiative by the BoDs was a definitive step towards promoting our Board beyond our borders and was well appreciated. The Board conducted its IBO Diplomates' meet this year at Hotel Courtyard by Marriott in Ahmedabad on the 21st May, 2022.

This was a hugely successful clinical meeting in which Diplomates from all parts of the country participated by sharing scientific presentations on very interesting clinical topics and scenarios. As is the norm in these meetings, we had some very meaningful discussions with a lot of clinical take home, this year too. For the first time this year, the BoDs introduced a very interesting session in this Diplomates' meet - a debate on a contemporary clinical topic. The topic for this meet was 'Aligner orthodontics - Is it the future of orthodontic treatment?' During this

debate, the group witnessed a very energetic, and interesting exchange of ideas and pointers from both speakers for and against the title, with some very pertinent conclusions drawn by the Chairmen at the end the session. On the 22nd May, 2022, the Board of Directors conducted the 2nd IBO Awareness program for the year at the Goenka Research Institute of Dental Sciences (GRIDS), Gandhinagar organized jointly by the Department of Orthodontics, GRIDS and Gujarat orthodontic Study Group which was attended by a big number of delegates from the region. Both these programs in Gujarat were hugely successful and applauded by the participants. The BoDs took the next step towards globalizing the IBO by conducting yet another IBO Awareness program in Kuwait on the 5th August 2022, organized by the Indian Dentist's Alliance in Kuwait (IDAK) along with the support of the Kuwait Dental Association (KDA). The entire program was coordinated by our own Dr. E.T.Roy, Diplomate IBO and Past Hon. Secretary, IOS, who is based in Kuwait. This program was well attended by orthodontists in Kuwait and was very much appreciated. The Chairman and the Directors in this trip also met with the Dean, Faculty of Dental Sciences, Kuwait university Dr. Rashed Al Hazemi, with a formal representation to look at the possibility of recognizing IBO Board certification at the level of the Kuwait Health Authority. 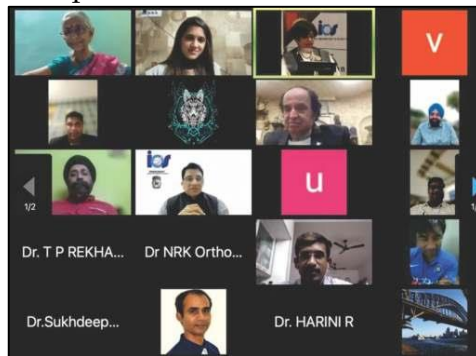

Cleft Lip and Palate an Orthodontic Perspective 2nd August 2022

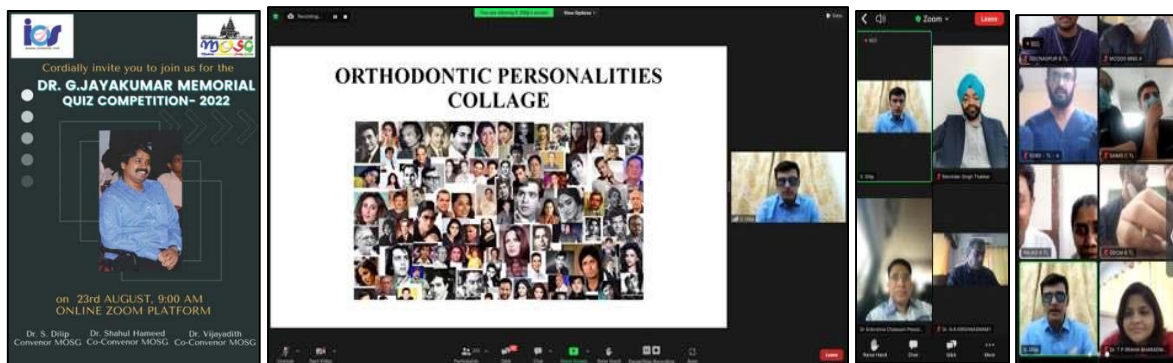
A CDE program on the topic “Cleft lip and palate – An orthodontic perspective” was held on 2-8-2022, in the

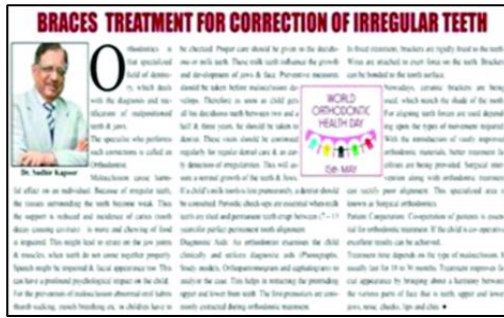

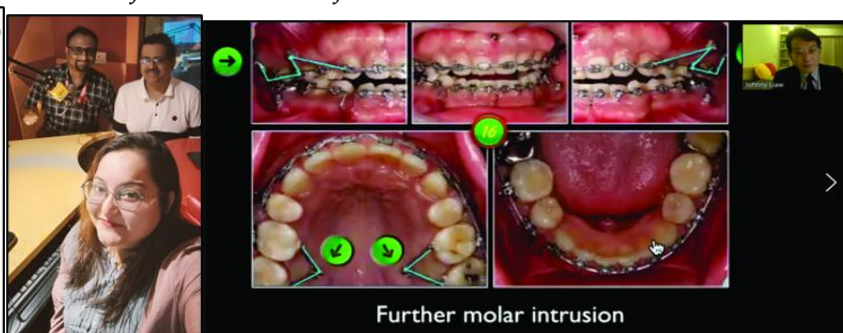

LIFE TIME ACHIEVEMENT AWARD

DR.V.SURENDRA SHETTY



Dr. V. Surendra Shetty joined the first batch of the College of Dental Surgery Manipal in 1965, which was the first dental college in the private sector in India. He went on to successfully complete the course in the year 1970, bagging the prestigious Dr TMA Pai Blue Ribbon Gold Medal for the Best Outgoing Student in B.D.S. for that year. He was also the State Award winner for standing first in the Mysore University for the year 1970. He then worked as a faculty for a short stint before continuing to pursue his Masters in Orthodontics in the same institution. He went on to complete his M.D.S. in the year 1974 following which he worked at K.M.C. Mangalore and was also teaching Orthodontics for undergraduates and postgraduates at MCODS Manipal until 1987. In January 1987, he was appointed the Director of the newly started Manipal College of Dental Sciences, Mangalore. It was a labour of love for him to oversee and be a part of the creation of the infrastructure and with his untiring efforts, dedication and discipline was able to propel the nascent college to greater heights to eventually occupy a position of eminence among other dental colleges of the country. He holds the unique distinction of being the Head of the same institution from its inception until the celebration of its Silver Jubilee in 2012 (a period of 25 years). Dr. Shetty has displayed leadership qualities, dynamism and as a proven and effective administrator and therefore in 2012 was called upon to shoulder further administrative responsibilities at Manipal University as Pro Vice Chancellor, in charge of the Mangalore Campus, a post he occupied till 2020. His academic involvement in the field of orthodontics has lead him to guide more than 75 Post Graduate Students, publish numerous articles in journals and deliver keynote addresses at several conferences and conventions. He underwent further training in orthodontics at Loma Linda University, California U.S.A. in the year 1991. Dr Shetty served with distinction and diligence as a member of various university boards. He was an Executive Committee member of the Dental Council of India from 1998-2003 and a member of Selection Committee for the W.H.O. Scholarship in the year 1998. He has also served as the Chairman, Government Task force Committee to review private dental colleges in Karnataka and was also a member of the Technical Committee of NABH for dental centers. He has served various

organizations in positions of responsibility. He is a past President of the Indian Dental Association, South Kanara District, past President of the Indian Orthodontic Society 1995, the Chairman Indian Board of Orthodontics 2008-2009. He was bestowed with the "Outstanding Professor" award for the year 2012 by the Indian Orthodontic Society. He had successfully conducted the National Conference of Indian Orthodontic Society at Mangalore in the year 1991. The most popular Orthodontic PG Student Convention of India was his brainchild, started in the year 1996, during his Presidentship of Indian Orthodontic Society. He was conferred with the 2015 New Year Award for distinguished services to the society in the field of education, profession and social service by the Academy of General Education Manipal, Manipal Academy of Higher education and Syndicate Bank. Through a disciplined, dedicated and diligent approach and with an eye for detail, Dr. V Surendra Shetty has made an indelible mark in the dental education and dental practice.




